### Terror attacks expose political immaturity

Residents have to collectively oppose the existence of armed groups to reduce terror acts, as these armed groups hamper the peace and stability of the region and destroy the security of residents.

SENIOR General Min Aung Hlaing noted that as terrorists commit attacks, taking covers from public houses in towns and villages and using people as human shields in their controlled areas, residents need to avoid them with conscientiousness and awareness in order to combat these terrorists successfully.

In a meeting with members of the Kayah State cabinet, departmental officials and town elders yesterday afternoon at the state government office, Chairman of the State Administration Council Prime Minister Senior General Min Aung Hlaing said so while talking about regional development measures.

In his speech, the Senior General recounted that towns and villages in Kayah State were damaged by KNDF and PDF terrorists in the recent period. Residents can forge peace and stability as well as undertake development tasks. Likewise, they can make attempts to delay development undertakings as well as jeopardize peace and stability. Terror attacks show lacking political maturity, he added.

He underlined that residents have to collectively bar the existence of armed groups to reduce terror acts, as these armed groups hamper the peace and stability of the region and destroy the security of residents.

The Senior General highlighted that as terrorists commit attacks, taking covers from public houses in towns and villages and using people as human shields in their controlled areas, residents need to avoid them with conscientiousness and awareness in order to combat those terrorists successfully.

The Senior General urged local authorities to reopen universities and arrange for students to attend the schools of their natives.

He unveiled that as Tatmadaw

started public healthcare services in Loikaw, residents needed to exercise a healthy lifestyle.

He continued that not only the government but also residents need to carry out rehabilitation tasks to enable all the regions to normalcy.

# Kyonekapyin-Tapseik records 160 bird species, including rare ones

Wildlife Conservation area, which is located in Shwe Laung sub-township, Wakema Township, Ayeyawady Region, described that it has recorded 160 bird species, including those which are listed as rare in the world, so people are invited to see and enjoy these birds, according to the Kyonekapyin-Tapseik Wildlife Conservation Group (KTCG).

Local conservation members have regularly conducted a programme to study and record the birds in the area every month. According to the records collected until August

THE Kyonekapyin-Tapseik 2024, a total of 160 bird species erbirds, scaly-breasted munia, Wildlife Conservation area, were recorded by the KTCG sparrow species, magpie robin,

Bird species found can be divided into three types-indigenous birds or species that breed in Myanmar, birds arriving in the rainy season to lay eggs and hibernating bird species that can only be found in the cold season.

Among them, the world's rare bird species are also found to be arriving, including cormorants, egret species, watercocks, moorhens, sarus cranes, kingfisher species, common ioras, crows, Cinnyris asiaticus and flowerpeckers, weav-

erbirds, scaly-breasted munia, sparrow species, magpie robin, red-whiskered bulbul, jerdon's babbler and wabler species, whose arrival can be seen the whole year to build nests and lay eggs, cuckoo species which come in the rainy season to lay eggs, and black-winged stilt, green sandpiper species, kites and eagles, white-faced wagtail and yellow-breasted bunting, that migrate in the cold season, according to the KTCG.

Therefore, people are invited to visit this bird conservation area to see and record these birds in detail with the help of local tour guides. — MT/ZN



# Nat-Test certificates and score reports released

NATTEST Exam Centre, Yangon, announced the schedule for taking out the certificate and score report of Nat-Test, which candidates sat for on 11 August 2024.

Certificate and score reports will be available from 31 August to 1 September for the N2 and N4 levels, from 2 September to 3 September for the N3 level and from 4 September to 5 September for the N5 level, from 10 am to 4:30 pm.

Certificates for all levels can be taken out in six months after 6 September. For coming in person, a copy of the candidate's ID card is required, or through a represented person, a copy of the candidate's ID card and a copy of the represented person's ID card are required, and it is ineligible to represent for more than two, and it needs to ensure accuracy of the registration number.

Training schools are required to submit the list of students on letterhead, along with accurate registration numbers, a day in advance.

Certificates are available at B-11, ground floor, Anawrahta Housing, Hledan (Insein Road, near Hledan bus stop) in Kamayut Township, Yangon. If required data are incomplete, the certificate and score report won't be given at all, it said. — MT/ZS

### SAC Chairman Prime Minister Senior General Min Aung Hlaing inspects rehabilitation of Hsihseng region damaged by terrorists in Pa-O Self-Administered Zone, provides aid to residents

A-O national races from villages around Hsihseng gathered their strengths, and they joined hands with Tatmadaw and the people's militia (local) to take the Hsihseng region back from the hands of terrorists as quickly as possible.

Hopong and Hsihseng townships in Pa-O Self-Administered Zone of Shan State (South) have suffered from impacts of loss and damage in terror acts perpetrated by PNLO, KNDF and PDF terrorists, which steadfastly commit subversive acts with attacks in towns and villages where local, national races reside, dropping bombs on religious buildings and schools and firing on these areas with heavy weapons. Still, they chant doing good deeds for the development of the regions.

Yesterday morning, Chairman of the State Administration Council Prime Minister Senior General Min Aung Hlaing, accompanied by his entourage, the Shan State chief minister and the Eastern Command commander, inspected the rehabilitation process in Hsihseng region.

The Senior General headed to Hsihseng along the Taunggyi-Hopong-Hsihseng road and viewed the peaceful daily

routine of the majority of Shan and Pa-O ethnic people and the progress of agriculture and livestock farming tasks.

In Hsihseng, the Shan State chief minister, Chairman of Pa-O Self-Administered Zone Administration Body U Khun Ye Htwe and officials reported on a plan to rebuild Hsihseng Myoma market damaged by terrorists.

The Senior General gave guidance on designing the new market as a modern facility with a proper area of shops and considered construction tasks with water and power supply and car

parks.

On arrival at the staff rental housing of the Department of Urban and Housing Development in Hsihseng, the Senior General heard reports on damage to the housing by terrorists and repairing process by officials and gave necessary instructions.

The Senior General paid homage to the assistant abbot of Zawanarama Monastery Buaddanta Pannasila and members of the Sangha and donated offerings.

In a meeting with departmental officials, local Tatmadaw members and families, members of the Myanmar Police Force, local people's militia members, and town elders in Hsihseng, the Senior General said that Hsihseng region where innocent Pa-O national races have been residing peacefully in successive eras faced loss and damage because of rebellious terror acts of opportunist PNLO terrorists.

Nobody should stop development tasks for a region or a country, and they have to march forward and work steadfastly. If they stop, they will lag in development. He emphasized that rehabilitation for damaged structures causes a delay in carrying out development tasks.

Only residents can undertake peaceful and stable measures as well as the development of the region. Likewise, residents also commit attempts to cause instability and delay the development tasks of the area. As such, residents have to cooperate with departmental staff, administrative bodies, and security forces to ensure peace and stability, rule of law, and development undertakings for the sake of their region.

He continued to say that departmental staff members have to emphasize the development of education, health, and socioeconomic improvement for the regions they serve in order to shape a better future for the area. The government and Tatmadaw will rehabilitate Hsihseng and its surrounding villages damaged by terrorists as much as possible, and residents have to participate in the rehabilitation process. Stopping development tasks is a loss for the region and the State, so all residents have to carry out development and peace and stability measures.

The Senior General presented foodstuffs and aid to local Tatmadaw members and families, residents and local people's militia.

Hsihseng of Pa-O Self-Ad-

ministered Zone is located at an altitude of 3,310 feet, sharing borders with Hopong Township in the north, Maukmai Township in the east, Kayah State in the south and Pekhon, Nyaungshwe and Taunggyi townships in the west. The majority of Pa-O national races peacefully reside in the township. Due to the persuasion and instigation of KNDF and PDF terrorists, the PNLO terrorist group committed terror acts against their ethnic Pa-O with intimidation for terrorism administration and building their power in the region without sympathy. As a result, the region lost peace and stability, whereas locals suffered a loss of socioeconomic life. Hence, as residents did not totally accept the terror acts of unfaithful PNLO terrorists, Pa-O national races from villages around Hsihseng gathered their strengths and joined hands with Tatmadaw and people's militia (local) in reclaim Hsihseng region from the combined terrorists as quickly as possible. The government and Tatmadaw are carrying out rehabilitation tasks in the Hsihseng area, and national races who temporarily left their regions for terror acts reentered there to earn their livelihood peacefully. — MNA/TTA

#### PhaungdawU Pagoda's sacred Buddha images to visit 21 places

IN line with the age-old tradition, the revered Buddha images of the Inlay PhaungdawU Pagoda, located in Nyaungshwe Township, Southern Shan State, will visit 21 places from 3 to 30 October.

The ceremonial procession will commence on the morning of 3 October at 4:00 am with an auspicious opening ceremony at the PhaungdawU Pagoda, where offerings will be made. At 7 am, the Buddha images will be relayed to the Intein Kyay Pawkhon Monastery, where they will stay overnight for worship.

Starting on 4 October, the images will continue their journey, visiting the Kyay Pawkhon Monastery, Intein San Monastery, and Heya Ywama San Monastery, where they will stay for two nights.

On the morning of 6 October, the images will move from Heya Ywama San Monastery to Ngar Phae Chaung Monastery, where they will stay overnight. On 7



October, the procession will continue from Ngar Phae Chaung Monastery to Kyae Sa Monastery for another overnight stay. The Buddha images will proceed from Kyae Sa Monastery to Pwesa Kun Monastery and Lin Khin

Monastery on 8 October.

Likewise, on 9 October, they will be carried from Lin Khin Monastery to Nyaungshwe Town Monastery, where they will reside for three nights. On 12 October, the images will travel from Nyaungshwe Town Monastery to Nan The Monastery and Mai Thauk Monastery. The next day, 13 October, they will move from Mai Thauk Monastery to Thale Oo Monastery, where they will stay overnight. On 14 October, the sacred images will visit Thale Oo Monastery, Kalaw Monastery, and Zarap Gyi Monastery for another overnight stay.

The procession on the Inlay waterway will continue on 15 October, moving from Zarap Gyi Monastery to the Alotawpauk Taung Monastery and Nam Pan Monastery. On 16 October, the images will travel from Nam Pan Monastery to Ma Kyee Sae Monastery and Kyaikan Monastery. On 17 October, they will move from Kyaik Kan Monastery to Maipyaw Monastery for overnight worship.

On 18 October, the Buddha images will be conveyed from Maipyaw Monastery to Nauk Taw Monastery, followed by a journey from Nauk Taw Monastery to Inpaw Khun Monastery and Yaytha Monastery on 19 October. Finally, on 20 October, the sacred images will return from Yaytha Monastery to their home at PhaungdawU Pagoda. — TWA/KZL

## Paung Tsp to host Mon traditional festival of 1,000 offerings

THE festival of 1,000 offerings, along with the Buddha Pujaniya Festival, will be held on 17 September at Kyaikpaung Pagoda in Paung Ward, Paung Township, Mon State, according to U Tin Pe, a member of the Kyaikpaung Pagoda board of trustees.

The donation of 1,000 types of alms is part of the Mon traditional Buddha Pujaniya Festival, celebrated annually on the full moon day of Tawthalin. The offerings, which include alms food, banners, flowers, incense, fruits, betel, and lights, are placed on a small ship made of wood and bamboo, following the Mon ethnic tradition.

"Each year on the full moon day of Tawthalin, the local community constructs the ship and loads it with nearly 1,000 different offerings, such as alms food, banners, flowers, incense, fruits, and lights, which are then offered to the Lord Buddha," said U Tin Pe.

As a cherished traditional festival of the Mon ethnic people, the alms festival, also known as the "1,000 Alms Food Offering Festival," and the offering of Satumadu (a type of medicine made from butter, sesame oil, honey, and molasses) are held annually in Mon State. — ASH/MKKS

Yangon Port handles 400+ container vessels in eight months

A total of 409 container vessels arrived at the Yangon Port in the past eight months (Jan-Aug) 2024, Myanma Port Authority announced.

Myanma Port Authority stated that 49 vessels in January, 53 in February, 55 in March, 50 in April, 52 in May, and 50 each in June, July and August called in the Yangon Port.

Yangon Port handled 629 container vessels in 2023. Thanks to the draft extension, the international ocean liners can access the inner port for now,

according to Myanma Port Authority's statement on 22 June 2022.

After the new navigation channel (Kings Bank Channel) accessing the inner Yangon River had been found, the draft extension work was accelerated. After that, the port can now handle larger ships. The container vessel MV SITC Zhaoming (185.99 metres LOA, 35.25 metres Beam, 29,232 GRT and 2,698 TEU) of Hong-Kong based SITC Shipping Line docked at Asia World Port Terminal for the first time on 22 June,

which is the largest ship that AWPT Port handled.

Since May 2021, the arrival of ships at terminals in Yangon has increased again. Three new container vessels by Maersk Line Myanmar (SeaLand Maersk) started to run to fulfil the seaborne trade requirements in 2021. Earlier, the larger ships had draft problems preventing sailing on the Yangon River. With the draft being extended up to 10 metres, more giant ocean liners can enter the Thilawa Port. — NN/KK

# Townships issue cooperative handbooks for palm oil purchases



SOME townships in Yangon Region have started giving cooperative handbooks in which all transactions of palm oil will be recorded.

"The ward administrator's office announced this over loudspeaker last night. Household registration is needed to be presented when buying palm oil with a handbook," Daw Thu Zar from Ward 14 of South Okkalapa Township told The Global New Light of Myanmar (GNLM).

This cooperative handbook will allow residents to buy palm oil as

per the set reference price starting in September.

Books are handed over to every household in some townships without asking for the household registration or citizenship scrutiny card, while administrators of some townships issue books after collecting lists, census and visitor registrations.

Those books are not allowed to be resold or used as a mortgage. Each household is entitled to hold one book. Palm oil can be purchased on the specified dates. Individuals need to report a lost book to the respective ward administrator. Those below ten years old are not eligible to buy them. — TWA/KK

#### MoPF regulates Myanmar-Thai international banking activities

THE Ministry of Planning and Finance has been systematically governing international banking activities between Myanmar and Thai banks to have sustainable development and maintain good relations with global financial institutions, the ministry announced on 2 September.

The statement revealed that global transfer through Myanma Economic Bank is to import the essential goods and intermediate goods that are requisite for Myanmar nationals.

Furthermore, Myanmar nationals opened bank accounts in Thailand for medical treatment, education, and inward remittance, which allowed migrant workers to legally transfer money back to their family members in the country, in line with the rules and regulations of the related banks.

State-owned banks conduct Due Diligence Procedures in line with the Central Bank of Myanmar's rules. Also, they comprehensively analyze Customer Due Diligence to assess customer risk and enhance due diligence (EDD) measures to minimize risks and maintain effective compliance. — NN/KK

For instance, infants need to hear sounds to learn to produce them, highlighting the interplay between these systems during speech development. Despite this connection, the high-level processing of voice production and perception occurs in separate systems. Voice production primarily involves the phonatory system located in the larynx, controlled by over 20 muscles, along with additional muscles linked to the jaw, sternum, and other parts of the body. The respiratory system also plays a critical role, as we need to exhale to speak, while the articulatory system, including the mouth, shapes the sound.

Similar to facial recognition technology, which identifies facial features and emotions, AI can analyze high-speed videos of vocal folds to classify various tissue structures automatically. This process eliminates the need for manual image examination, making it feasible to analyze extensive datasets rapidly. We despecific features within these videos, enabling us to study the movement and behaviour of different tissues comprehensively.

AI operates in two primary ways in our research. First, it captures and processes information that is visible but difficult to analyze manually due to the volume of data. Second, AI uncovers hidden information that aids in the differential diagnosis of voice disorders. For instance, AI can detect subtle variations in voice quality, such as breathiness or strain, which are challenging to identify otherwise.

One remarkable capability of AI is its ability to analyze temporal data – information spread across time. In just one minute of recording, we might have around 300,000 images. Instead of teaching AI-specific features to look for, we can provide it with raw data and let it perform a complex, trial-and-error analysis. Although we guide the AI in this process, it largely operates independently, extracting features and creating a comprehensive information map. This approach allows for a broader range of speech, enabling the person to speak various words, vowels, and consonants. We recently utilized this technique for data collection at the Mavo Clinic in Arizona. This method is particularly beneficial for studying task-specific voice disorders, where symptoms vary significantly based on what the person is saying. For instance, someone might be able to say "Aaaaah" without issue, but problems arise when they start speaking in sentences. This disorder, known as laryngeal dystonia, is rare and particularly interesting because it can affect specific activities like singing while leaving normal speech unaffected. We are currently studying a subject with this condition to gain a deeper understanding of

Our ongoing research into laryngeal dystonia has yielded intriguing results. We are exam-

models to investigate how airflow from the lungs interacts with the vocal folds and how tissue movements generate sound. These models help us understand what happens if there is a disruption in these systems, how it manifests in a person's voice, and how we might develop treatment strategies for such anomalies.

Regarding the singer's dystonia, which affects only the singing voice, one hypothesis is that it could be an early indicator of a neurological disease. Voice production involves the precise coordination of the respiratory system and vocal fold vibrations. Any disorder affecting these systems, such as a neurological or mental health issue, will reflect in the voice. Artificial intelligence (AI) holds great potential for creating personalized models of a person's voice by summarizing various measurements and information. For example, surgeons dealing with laryngeal cancer currently use extensive questionnaires to decide on treatment approaches. AI could streamline this process by providing summarized, relevant information based on the disorder's pathophysiology. However, AI will likely not replace the nuanced decision-making of doctors, who rely on real experience to make informed choices.

Our research goal is to develop protocols that can be used clinically. We aim to understand the fundamentals of voice production and how various factors. such as mental health status or treatments like radiation therapy for laryngeal cancer, might affect it. Laryngeal cancer is of particular interest because it has one of the highest suicide rates among cancers, possibly due to its impact on the ability to communicate.

We strive to use our under standing of voice to improve clinical diagnoses and create accurate, individualized treatment approaches. Additionally, we are exploring the use of voice as a biomarker for other health issues. We have started data collection at Henry Ford Health and anticipate obtaining intriguing results from these projects soon. Our ultimate aim is to enhance the diagnostic and treatment capabilities for voice-related disorders and other health conditions reflected in the voice.

#### Embassies announce Myanmar passport fee changes this month

THROUGH their social media pages, Myanmar embassies in some countries have made announcements on changes of Myanmar passport fees as of this month.

Myanmar Embassy in the Republic of South Korea will raise the passport extension charge to 55,000 Korean won from 48,000 Korean won as of 1 September.

In Japan, the passport extension fee will change to 6,000 yen from 5,000 yen on 1 Sep-



tember, and the fine for expired passports and lost passports will remain unchanged.

Similarly, the Myanmar Embassy in Singapore will change the passport extension fee to SGD65 from SGD60, taking effect from 1 September. However, an SGD125 fine for

a lost passport, an SGD35 fine for an expired or damaged passport, and an SGD45 fine for a passport that has been valid for more than a year will remain unchanged.

In the Philippines, the Myanmar passport extension fee will change to US\$40 from \$35 as of 1 September, and the embassy has set a \$105 fine for a lost passport.

Embassies in other countries have also made similar announcements. — MT/ZS



THE government has been making efforts to bring back Myanmar nationals who are encountering difficulties abroad by coordinating with the Myanmar Consulate-General and relevant embassies to ensure their safe return to Myanmar.

The Myanmar Embassy in Saudi Arabia communicated with the authorities of Riyadh to repatriate two Myanmar female citizens, Ma Sabai Phyu and Ma Ni Ni Win, who faced hardships in Mecca and Howtat Bani Tamin by flight on 3 September, and they arrived in Yangon yesterday afternoon.

# YBS accidents in 8 months: 30 dead, 89 hurt

OVER eight months this year, there were 30 deaths and 89 injured persons from YBS accidents, according to Yangon Region Public Transport Committee (YRCT).

In January, there were seven YBS accidents that left four fatalities and seven hurt. Five YBS accidents in February left four deaths and three injuries, eight YBS accidents and two other cases in March caused four fatalities and 22 injuries, and three YBS accidents and one case in April caused two deaths and two injuries.

Seven road accidents in May left four deaths and five injured, five road accidents in June left three deaths and three injuries, eight road accidents and another one case in July left seven fatalities and 32 wounded, and there were five road accidents and another one case in August, left two deaths and 15 injured, according to YR-

TC's statistics.

Under casualty data collected until 29 August, 12 pedestrians and nine cyclists were killed in YBS accidents. two people died from falling from a bus, two people were killed in a collision with a motorcycle, and a further two people were dead from a collision with a private car; one person was dead from a collision with a taxi, one person was dead from a collision with a truck, and another one died from other case happened aboard.

From January until August, YRTC organizes seminars monthly to educate undisciplined YBS drivers about road safety, and so far, 1,296 drivers have been included. There are 21 YBS companies under the management of YRTC, and 131 bus lines commute about 1.4 million passengers daily by 3,800 buses. — MT/ZS

#### Illegal goods worth K814.6M seized across multiple townships

UNDER the supervision of the Illegal Trade Eradication Steering Committee, efforts to combat illicit trade are being effectively made to take effective action in accordance with the law.

On 3 September, combined duty teams under the management of the Customs Department made inspections. Two kinds of industrial materials worth K108.721 million that were different from the Import Declaration (ID) were captured from three containers at the Asia World Port container checkpoint, and two kinds of industrial materials valued at K86.549 million that were different from the ID were also impounded from two

containers at the Myanmar Industrial Port. The action was taken in accordance with Customs procedures.

Additionally, the combined teams captured two Nissan Diesel trucks (approximately worth K100 million) carrying ten kinds of industrial materials worth K98.231 million without official documents at the Kyweltatsone checkpoint, two trucks (approximately worth K110 million), heading to Taunggyi from Hopong, carrying nine kinds of industrial materials and two kinds of consumer goods worth K69.785 million without official documents beyond the Aungthapyae tollgate in Ayethaya township and three buses (estimated value of K85 million), travelling from Hpa-an to Mandalay, carrying ten kinds of foodstuffs, two sorts of consumer goods and industrial materials valued at K84.059 million without official documents at the Thanlwin Bridge (Tayothla side) combined checkpoint. The action was conducted in line with Customs procedures.

On the same day, the combined on-duty teams captured industrial materials worth K11.491 million without official documents in Kawthoung township, an unregistered Toyota Probox (estimated value of K3.5 million) in Mingaladon township

and a total of 1.394 tonnes of illegal teak and 9.345 tonnes of other timbers worth K442,051 in Lewe and Ottarathiri districts. The action was carried out under Customs procedures, the Export and Import Law and the Forest Law.

On the same day, the combined teams conducted inspections, resulting in the seizure of illegal teak weighing 1.07 tonnes and illegal other timbers weighing 1.108 tonnes worth K1.093 million in Bago and Toungoo districts and an unregistered motorbike (estimated value of K1.5 million in Natmauk township. The action was executed under the Export and Import

Law.

Moreover, on 4 September, the combined teams conducted inspections resulting in the seizure of three unregistered vehicles and seven unregistered motorbikes (estimated value of K54.2 million) in Pathein, Pyapon, Hinthada, Myaungmya and Maubin districts. The action was taken under the Export and Import Law.

In total, from 3 and 4 September, a total of 46 cases were logged, resulting in the seizure of illegal commodities valued at approximately K814.573 million, according to the Illegal Trade Eradication Steering Committee. — MNA/MKKS

# Japan eyes new business support measures to improve food security

JAPAN'S agriculture ministry is mulling a new support system for food technology and agricultural businesses to improve the country's food security, sources familiar with the matter said Tuesday.

The plans come as the government seeks to ensure a stable supply of food at fair prices, addressing concerns over availability due to rising import costs related to the war in Ukraine, as well as production challenges arising from climate change and fewer domestic producers.

The Ministry of Agriculture, Forestry and Fisheries is considering steps to support partnerships between farming businesses and food makers, as well as tax incentives and low-interest loans for firms developing technology for food production and to minimize the environmental impact.

The proposed support includes facilitating partnerships between farming and food businesses, offering tax incentives, and providing low-interest loans for food technology advancements.



The provisions are expected to be included in the government and ruling parties' year-end outline on reforms to the tax system, with related legislation expected to be submitted to the 2025 ordinary Diet session.

Revisions to the law on food, agriculture and rural areas passed in May have made food security one of its basic principles, with the amended law including provisions to promote businesses that contribute to sustainable food supplies.

As medium- to small-sized firms make up the majority of Japan's food producers, strengthening their business foundations is an issue for the government. It plans to encourage small businesses to grow larger through business successions and mergers and acquisitions. — Kyodo

# Report highlights New Zealand's weak grocery competition

Prices at the checkout are increasing faster than wholesale costs, with supermarket profit margins remaining high. This suggests a lack of genuine competition in the \$25 billion grocery sector.

NEW Zealand's first annual grocery report published on Wednesday highlighted the

weak grocery competition, and broader, structural problems with the country's trading, planning and regulatory systems.

The report underscored the need for reforms to cut red tape and promote competition, said Commerce and Consumer Affairs Minister Andrew Bayly.

Checkout prices have been rising more than wholesale costs, with supermarket margins increasing, and profit levels remaining higher than expected in a genuinely competitive market, said the report which painted a concerning picture of New Zealand's 25 billion-New Zealand dollar (US\$15.4 billion) grocery sector. — Xinhua

### EU auditors warn of bloc's pandemic recovery fund delays

BILLIONS of euros available for EU states to boost their economies hit hard by the coronavirus pandemic are not reaching citizens and businesses fast enough, the bloc's spending watchdog warned Monday.

The European Union established the 800-billion-euro (\$900 billion) fund, known as the Recovery and Resilience Facility (RRF), during the pandemic, financed in large part through common EU borrowing.

"The first three years of the EU's... RRF have seen delays in funds being disbursed and projects being implemented," the European Court of Auditors (ECA) said.

EU countries had drawn down less than a third of the planned recovery funds at the end of 2023, the auditors said.

"This put at risk the achievement of goals for helping EU countries recover from the Covid-19 pandemic and making them more resilient," it added in a statement.

The bloc agreed on the unprecedented mechanism in July 2020 after bitter negotiations in the face of opposition from frugal countries led by The Netherlands.

The countries, mainly in northern Europe, feared having to foot the bill for higher spending in their southern neighbours.

Italy and Spain are some of the main beneficiaries of the funds. To get the money, the 27 member states had to submit national investment plans linked to structural reforms. Money would then be disbursed by the commission if the countries achieved certain objectives. — AFP

#### TotalEnergies to invest \$444 million in solar venture with Adani

INDIA'S Adani Group will set up a joint venture with TotalEnergies to manage a 1,150-megawatt portfolio of solar projects in the western state of Gujarat, the company said Tues-

The deal, which will expand business ties between Indian billionaire Gautam Adani's conglomerate and the French firm, will see Adani Green Energy (AGEL) contribute its "current assets" to the new joint venture.

TotalEnergies will invest \$444 million to "accelerate the development of these projects".

A separate exchange filing said that AGEL and TotalEnergies will hold an equal stake in the tie-up.

AGEL is 19.75 per cent owned by TotalEnergies.

"The projects are located at the world's largest renewable energy plant in Khavda, Gujarat," AGEL said in a statement.

The Khvada site will extend over 538 square kilometres (207 square miles) — five times the size of Paris - and is aimed to produce solar and wind capacity of 30 GW, with 2GW already being produced by AGEL, TotalEnergies said in a statement. The electricity generated from the projects will be sold through purchase agreements with the Solar Energy Corporation of India and through sales on the wholesale market.

"This new transaction will allow TotalEnergies to capitalize on the ongoing liberalization of the Indian electricity market," TotalEnergies said.

TotalEnergies has also been rapidly developing renewable electricity production, with 22 GW of installed gross production capacity at the end of 2023.

It aims to expand this to 35 GW by 2025.

The Adani Group, a sprawling ports-to-power conglomerate, saw \$150 billion wiped from its market value in early 2023 after a bombshell report by US-based short seller Hindenburg Research accused it of "brazen" corporate fraud. — AFP

### Sekisui mulls turning Sharp Osaka plant into next-gen solar cell hub

The aim is to transform the site into a production facility for next-generation perovskite solar cells.

SEKISUI Chemical Co is considering acquiring part of Sharp Corp's plant in Osaka Prefecture in a bid to make the obsolete factory a production hub of next-generation solar batteries, sources familiar with the matter said Wednesday.

The Japanese chemical firm plans to produce perovskite solar cells at the site, the sources said. The thin, light, flexible solar batteries are designed to be installed in places where existing solar cells cannot be attached such as curved surfaces and the exterior walls of buildings.

The technology has been drawing attention in recent years as a way to significantly increase solar power generation. Japan's industry ministry is likely to subsidize the project as it is expected

to contribute to decarbonization, according to the sources.

Perovskite solar cells are made mainly from iodine and Japan is the second largest producer of the element in the world. The relative ease in building domestic supply chains is another reason the technology is being backed by Japan as it seeks to strengthen its economic security. — Kyodo

#### German govt to reduce stake in Commerzbank

THE German government will gradually reduce its stake in Commerzbank which it built up when the country's second-biggest lender ran into trouble during the global financial crisis, authorities said Tuesday.

"The bank's economic situation has been steadily improving since 2021," said Eva Grunwald, head of the federal finance agency, in a statement.

The bank was pushed to the brink of bankruptcy during the financial crisis, prompting Berlin to commit huge sums to prop it up in 2008 and 2009.

The state still holds a 16.5 per cent stake in the lender. The finance agency did not give a timetable for the withdrawal.

The bank has gone through several rounds of cost-cutting and restructuring over the years.

But in recent times, like other banks, its results have been boosted by higher eurozone interest rates. — AFP

### Pope makes appeal on extremism as he launches Asia tour

Pope Francis highlighted self-interest as a barrier to religious unity and a cause of global conflicts.

POPE Francis began his historic Asia-Pacific tour with a visit to Indonesia, meeting President Joko Widodo and promoting interfaith harmony in the world's largest Muslim-majority nation, as he embarked on the longest trip of his papacy at age 87.

Pope Francis appealed Wednesday for religious unity to counter extremism and intolerance, as the longest tour of the 87-year-old's papacy got into full swing in Muslim-majority Indonesia.

On the first full day of his four-nation trip to the Asia-Pacific, the pontiff zeroed in on the role all faiths can play on flashpoint security issues.

"In order to foster a peaceful and fruitful harmony that ensures peace... the Church desires to strengthen interreligious dialogue," the pope said in a speech after meeting President Joko Widodo.

"(Extremists) through the distortion of religion attempt to impose their views by using deception and violence".

The pope criticized self-interest as a barrier to religious unity and a cause of global conflicts. He and Indonesian President Widodo called for greater freedom and tolerance in a world marked by unrest.

#### Indian Coast Guard helicopter crash in Arabian Sea

TWO bodies have been recovered after three crew members went missing as an Indian Coast Guard (ICG) helicopter crashed into the Arabian Sea, while search for the third one is underway, officials said Wednesday.

The bodies of the helicopter pilot and its diver were recovered on Tuesday night.

According to the ICG, the Advanced Light Helicopter (ALH) crashed into the Arabian Sea off Gujarat's Porbandar coast on Monday night.

"On Monday ICG ALH was launched at 11 pm to evacuate an injured crew member from the Motor Tanker Hari Leela off Porbandar, Gujarat. The helicopter had to make an emergency hard landing and ditched into sea. One crew member recovered, search for the remaining three crew members is in progress," the ICG in an initial statement said. — Xinhua

#### Egypt's 1<sup>st</sup> intl airshow kicks off with global performances

THE first edition of the Egypt International Airshow kicked off on Tuesday at a northern airport in the country, with flight performances by air forces from Egypt, China, and other countries.

Egyptian President Abdel-Fattah al-Sisi inaugurated the airshow, which is scheduled to run from Tuesday to Thursday at El Alamein International Airport in El Dabaa, Matrouh Governorate, the Egyptian state TV reported. The event has attracted more than 300 aviation and aerospace companies and agencies, as well as relevant authorities representing about 100 countries and regions, according to the

report. Among the participants are several Chinese companies, which have brought with them scale models of different types of aircraft, including China's self-developed large passenger aircraft, the C919. The first day of the airshow began with a flight performance by the Egyptian Air Force's Silver Stars. Air forces from China, the United States, France, Italy, the Czech Republic, Saudi Arabia, the United Arab Emirates, Türkiye, and India also presented their flight performances, including a notable solo display of the Y-20, China's domestically developed large transport aircraft. — Xinhua

#### Switzerland reopens embassy in Baghdad, Iraq after 33-year hiatus

SWITZERLAND has reopened the embassy in the Iraqi capital of Baghdad after it was closed in 1991 due to the Gulf War, the Federal Department of Foreign Affairs said on Tuesday.


"As of today, Switzerland once again has a diplomatic presence in Iraq. The previous embassy was closed in 1991 due to the 1991 Gulf War.
